

THE GOVERNMENT OF THE REPUBLIC OF CROATIA

Pursuant to Article 30, paragraph 2 of the Act on the Government of the Republic of Croatia (Official Gazette 101/98, 15/2000, 117/2001, 199/2003, 30/2004), based on the provision of the Decision establishing a negotiating structure for the accession of the Republic of Croatia to the European Union, Class: 910-04/00-03/06, Reg. No.: 5030109-05-21 of 7 April 2005, at its session of 2 February 2006 the Government of the Republic of Croatia adopted the

DECISION

amending the Decision on the appointment of the members of the State Delegation of the Republic of Croatia for negotiations on the accession of the Republic of Croatia to the European Union, the members of the Negotiating Team for the accession of the Republic of Croatia to the European Union, the heads of Working Groups for preparing negotiations on the individual chapters of the *acquis communautaire*, the members of the Office of the Chief Negotiator and the members of the Secretariat of the Negotiating Team

I.

The Decision on the appointment of the members of the State Delegation of the Republic of Croatia for negotiations on the accession of the Republic of Croatia to the European Union, the members of the Negotiating Team for the accession of the Republic of Croatia to the European Union, the heads of Working Groups for preparing negotiations on the individual chapters of the *acquis communautaire*, the members of the Office of the Chief Negotiator and the members of the Secretariat of the Negotiating Team, Class: 910-04/00-03/06, Reg. No. 5030109-05-23 of 7 April 2005 and Reg. No. 5030109-05-55 of 7 October 2005, shall be changed in section IV, subsection 30 to read as follows:

"30. Tatjana Tomić, Head of Department, Ministry of the Economy, Labour and Entrepreneurship – working group for External relations;"

II.

Section V, subsection 4 shall be changed to read as follows:

"4. Maša Ivaniš, Ministry of Foreign Affairs and European Integration – Public Relations adviser;"

Behind subsection 4 subsections 5 and 6 shall be added to read as follows:

"5. Ivana Noršić – adviser-analyst:

"6. Mario Zeljko, Ministry of Foreign Affairs and European Integration – adviser for the implementation of the Stabilisation and Association Agreement and the Pre-accession Strategy."

III.

In section VI behind subsection 13 subsection 14 shall be added to read:

"14. David Hrvoje Hoić, Ministry of Foreign Affairs and European Integration, responsible for coordination of general tasks and jobs arising from negotiations, within the scope of the Secretariat of the Negotiating Team."

IV.

This Decision shall enter into force on the day of its adoption and shall be published in the Official Gazette.
