Pursuant to Article 30, paragraph 2 of the Act on the Government of the Republic of Croatia (Official Gazette 101/98, 15/2000, 117/2001, 199/2003 and 30/2004), and the provisions of the Decision establishing a negotiating structure for the accession of the Republic of Croatia to the European Union (Official Gazette 49/2005 and 46/2006), at its session on 7 February 2008, the Government of the Republic of Croatia adopted the following

DECISION

AMENDING THE DECISION ON THE APPOINTMENT OF THE MEMBERS OF THE STATE DELEGATION OF THE REPUBLIC OF CROATIA FOR NEGOTIATIONS ON THE ACCESSION OF THE REPUBLIC OF CROATIA TO THE EUROPEAN UNION, THE MEMBERS OF THE NEGOTIATING TEAM FOR THE ACCESSION OF THE REPUBLIC OF CROATIA TO THE EUROPEAN UNION, THE HEADS OF WORKING GROUPS FOR PREPARING NEGOTIATIONS ON THE INDIVIDUAL CHAPTERS OF NEGOTIATIONS - ACQUIS COMMUNAUTAIRE, THE MEMBERS OF THE OFFICE OF THE CHIEF NEGOTIATOR AND THE MEMBERS OF THE SECRETARIAT OF THE NEGOTIATING TEAM

I
